*General Account*

Beginning balance September 2021 was \$213,651.71. Income received \$41,157.03. Expenses \$7,776.82. Leaving a balance of \$247,031.92.

*Library Account*

Beginning balance for September 2021 was \$86,027.74 Income received \$633.76. Expenses \$2,286.21. Leaving a balance of \$84,375.29.

*Tax Account*

Beginning balance for September 2021 was \$47,767.20. Income received \$197,624.40. Expenses \$243,396.07. Leaving a balance of \$1,999.46.

Beginning balance for September 2021 was \$10,876.73. Interest income of \$14.89. Account was CLOSED OUT \$10,891.62.
