**Treasurers Report**

*General Account*

Beginning balance February 2023 was \$412,701.63. Income received \$6,345.74. Expenses \$11,255.13. Leaving a balance of \$407,792.24.

*Library Account*

Beginning balance for February 2023 was \$83,307.12 Income received \$23.66. Expenses \$3,501.52. Leaving a balance of \$79,829.26.

*Tax Account*

Beginning balance for February 2023 was \$1,028.89. Income received \$253,648.09. Expenses \$163,549.48. Leaving a balance of \$91,127.50.

**Clerks Report**

*Jeff Stein Fire Department-* Is seeking bids for a new fire truck. He has two new crew members. Is waiting on new truck for medical runs.

*Lake County Sheriff's Department-* Problems internally with prosecutors office have been negatively effecting his department. Is waiting on a bill to go through with the state concerning ATV enforcement. Would like to have an all around recreation enforcement that could go through the seasons and be certified for all. Is working with another township to store current recreation patrol equipment such as snowmobiles, boat and trailer, etc.

Commissioner Howard Lodholtz- Gave an update on what the commissioners are currently working on.

*Library representative-* Joyce Beach library president gave an update on what the board is working on. They are interested in making an outdoor seating area, resident and business owner Corey Miller offered to donate cement work. Benches may be offered for purchase by business or individuals with advertisement plaques. Librarian wages will increase to \$15 per hour effective April 1<sup>st</sup> 2023.

Library cleanout is April 14<sup>th</sup> and 15<sup>th</sup>, will have a dumpster for cleanout of the library basement.

**New Business:**

Household Hazardous Waste- Will be held Thursday August 3<sup>rd</sup> 2023 from 4-8pm this will be held in Osceola County. The event will be alternated between Lake and Osceola counties due to the loss of a contractor and increase in costs.

Phil Lodholtz made a motion to contribute \$250.00 to Mecosta, Osceola, Lake Conservation District for the household hazardous waste program. Seconded by Joyce Beach. Motion passed unanimously.

**Old Business**

*Cinderblock building removal-* There is asbestos in the windows and roofing and will have to have sprayed down during removal, Reed City Fire Chief Jeff Stein agreed that the fire department will be able to help with that.

*Traffic Trailers-* Officer Chad Hurley gave an update on the effectiveness of the traffic trailers since being installed on US10 in Chase. They show that there is a reduction in speed as well as officers have been patrolling and writing tickets to speeders.

Amy Patterson made a motion to transfer possession of traffic trailers to Lake County Sheriffs department to help with liability, theft, and insurance purposes. Seconded by Phil Lodholtz. Motion passed unanimously.

Library playground project- Clerk Amy Patterson submitted another report to Lake County for arpa funds and project projections. Once the frost laws are off and contractors can begin dirt work and then installation of equipment. Will be looking for volunteers and contractors for additional help.

Generator at Hall- Joe Shoemaker has been waiting on Consumers to do a power disconnect and reconnection on the same day. The company has been scheduling but he didn't want to complete it during the winter months because of the cold temperatures. Should be completed soon.
